IPC Membership Call follow-up

Dear Paralympic friends,

Thank you for your time and participation in the post-Governing Board IPC Membership calls last week. We wanted to follow up with you regarding requests to share information on the NPC Ukraine Charitable Donation Fund, and on the Strategic Planning survey to members.

1. NPC Ukraine Charitable Donation Fund

We write to inform you that NPC Ukraine has set-up a Charitable Donation Fund to which anyone can make a donation in USD, EUR or PLN. Full details of the fund are on the next page of this letter.

Due to the ongoing conflict, members of the NPC Ukraine delegation travelled to Poland following the Beijing 2022 Paralympic Winter Games. Since then, some members have travelled back to Ukraine to be with friends and family, while some of the core team has travelled to Finland. Thanks here must go to the NPCs of Poland and Finland for their outstanding support provided so far, in addition to the support of several other of our members.

The Charitable Donation Fund has been established by NPC Ukraine. Money raised through donations will be spent on the most immediate requirements which include travel, food, clothes, accommodation and medical supplies. Currently more than 300 people, including many children with disabilities, are staying at the NPC Ukraine Training Centre in Western Ukraine after fleeing their homes.

The Charitable Donation Fund will also be used to pay for training and entry into major competitions for Ukrainian Para athletes. It is testament to the courage of the delegation and the power of sport, that NPC Ukraine is still training its athletes to compete in major Para sport events later this year. Any support International Federations can also provide Ukrainian athletes to compete in major events will be gratefully received by the NPC.
